D. SAFETY COMMITTEE'S REPORTS

D1. Safety Inspection at Member Agencies

Conor Boughey reported that the purpose of today's meeting is to seek feedback from the Safety Committee to determine if MBASIA should engage with a loss control firm to provide services, and if so, what type of services to focus on.
