Jamie Goldstein reported out of closed session that the Board reviewed the 3 agenized claims, and final action was taken on the Oster v. Capitola claim while no reportable action was taken on the other two claims.

## C2. Investment Update of Transfers

Lorissa Huey reported that the Board's goal was to fund the Chandler long term investment account with up to $\$ 12 \mathrm{M}$, staggering deposits to continue to purchase at higher yields as bond rates have risen. The account is funded with $\$ 8 \mathrm{M}$ due to two prior $\$ 4 \mathrm{M}$ deposits.

A motion was made to transfer $\$ 2 \mathrm{M}$ from LAIF to Chandler effectively immediately, and then at the Strategic Planning in November 2022, revisit transferring another \$2M.
